**NOTIFICATION**

Whereas in exercise of the powers conferred under Section 3 of the West Bengal Right to Public Services Act, 2013, the online land allotment system to intending investors for Electronic Manufacturing Clusters, IT/ ITeS Parks & Hardware Parks has duly been notified as a service. And therefore, the Governor of West Bengal is pleased to appoint the following Appellate Authority to hear and decide appeals against the orders passed by the competent authority as laid down under the Section 6 of the West Bengal Right to Public Services Act, 2013. The structure of the appellate provision is as follows.

- i) Against the Junior Officer (ID&M) regarding verification of documents –Deputy Manager (ID&M), WBEIDC Ltd (Webel)
- ii) Against the Deputy Manager (ID&M) regarding verification of documents –Deputy General Manager (ID&M), Webel
- iii) Against DGM (ID&M) regarding the payment verification - Managing Director, Webel
- iv) Against RMC committee regarding the recommendation and shortlisting- Managing Director, Webel
- v) Against Executive Director, Finance regarding the review of recommendation - Managing Director, Webel
- vi) Against the Managing Director, Webel on final approval with digital signature- Additional Chief Secretary, Department of Information Technology and Electronics, Govt. of West Bengal
- vii) Against the Webel Board on final approval on case to case basis- Additional Chief Secretary/Principal Secretary/Secretary to the Government of West Bengal in the Department of Information Technology and Electronics, as the case may be.

This notification will come into force on and from 10<sup>th</sup> August 2017.
