ORDER

Subject:- 'Constitution of a Special Committee on clearance for installation of Mobile Towers and laying of OFC under West Bengal Broadband Policy, 2020'.

In line with the guidelines issued by the Secretary, Department of Telecommunications, Govt. of India vide their D.Q. No 16-08/2015-CS-III dated 16.9.2015 and invoking provisions laid down under Para 10(a) of the West Bengal Telecom Infrastructure Guidelines, 2020 For Clearance and Permission to set up Mobile Tower or Base Tower Station (BTS) and Laying of Optical Fibre Cable (OFC) notified vide no. 585-Estt-ITE/20012/2/2020 dated 28.12.2020, a *Special Committee is hereby constituted* for clearance of Mobile Towers and laying of OFC under West Bengal Broad Band Policy 2020 as amended up to date and for smooth roll out of 5G telecommunication infrastructure at various urban municipal corporations viz. Howrah Municipal Corporation, Asansol Municipal Corporation, Durgapur Municipal Corporation, Siliguri Municipal Corporation, Chandennagore Municipal Corporation and Bidhannagar Municipal Corporation.

The Committee shall have the following composition:

1. Commissioner- Chairman in ex-officio capacity.
2. Joint Municipal Commissioner- Member Convenor
3. Representative of the Law Enforcement Agency- Police Department- Member.
4. Representative of the Fire & Emergency Services Department- Member.
5. Representative of the Public Works Department - Member.
6. Representative of the Environment Department- Member.

This committee will have powers akin to the District Magistrate in a district as laid down under para 4(b) of the said guidelines.

Representative of Telecom Service Providers and Telecom Infrastructure Companies as well as from TERM Cell, Department of Telecommunications, Government of India may be coopted during the meeting as special invitee, as and when deemed necessary.

The Commissioner of the aforementioned Municipal Corporations is advised to constitute this committee and convene its first meeting within 30 working days from the date of this order.

This has the approval of the Principal Secretary, IT&E Department, Govt. of West Bengal.

The order takes immediate effect.
